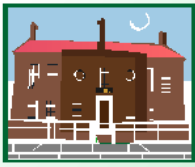

Parent / Guardian Agreement

1. All children must strictly adhere to the teachings of Islam. Students must show respect to their teachers and other students at all times.
2. I agree that my child/children will comply with all the current regulations of the Madrasah.
3. I agree that the parent/guardian will be held fully responsible for the cost of any damage the student may have caused to the property of the Madrasah. I indemnify EEIS against any damages or injuries during the child's attendance at the Madrasah. It is a duty upon every student to take care of their belongings. If lost, the Madrasah will not be responsible.
4. I agree to drop off my child/children from 10.20am for class to start promptly at 10.30am. In the interest of child safety **the doors to the Masjid will be locked at 10.45am** and re-opened for the Zuhr Salah. It is my responsibility to collect my child/children no later than 10 minutes after the Zuhr Salah is completed from **inside** the Masjid. The EEIS will not be held responsible for the children outside of these times. No child will be let outside to meet parents or cross the road on their own. No student is allowed to leave the Madrassah premises without prior parental or guardian notification and EEIS approval.
5. I will endeavour to park respectfully and show full consideration to the local residents and Masjid neighbours.
6. I agree to pay the fees promptly (6 months = £105, Fully Year = £200). Fees will not be refunded in any circumstance. This includes students being asked to leave the Madrasah according to EEIS Policies or leaving the Madrasah of their own accord.
7. The Madrasah welcomes any positive and constructive feedback. Any concerns parents may have should be put forward respectfully to the Chairman / Imam. Any abusive behaviour directed towards the trustees, teachers or staff of the Madrasah will not be tolerated and may lead to dismissal.
8. I confirm that my child will adhere to the Madrasah uniform as mentioned in the EEIS Madrasah Policies & Procedures.
9. I agree to supervise and ensure my child/children complete any homework that has been set each week by the Madrasah. I will check any letters sent with my child/children and will act accordingly.
